800 m and 1500 m Free will close early if Full, with reserves.

Entry to both the 800m and 1500m Freestyle is restricted to 3 heats (800m) & 2 heats

(1500m), no extra heats will be added to these events.

Awards Top 3 Male/Open & Female swimmers in each age group per event.

Entry Acceptance: Entries will be accepted on a **FIRST COME, FIRST SERVED** basis. The closing date for entries is 11:59 PM on 23/11/2024, or **WHEN FULL*** if earlier.

*The meet will be deemed full when the session time reaches 3.5 hours

Processed Entries: A list of processed entries will be published on **28/11/2024**. Competitors are requested to check their entries carefully and inform compsec@ boltonmetro.com immediately of any errors.

Poolside Passes

In compliance with the new Swim England policy concerning the supervision ratio, Bolton Metro is committed to alleviating the financial burden on participating clubs. Therefore, there will be a flat fee of **15.00 per club***, regardless of the number of coaches and/or team managers present poolside.

All team staff must be DBS checked and have undertaken a relevant safeguarding course (e.g., Swim England Safeguarding course) to gain a coaches/team manager pass and access to the poolside and the swimmer's seating area. Any parent of a swimmer attending without their club wishing to chaperone their child must also be DBS checked to gain a pass. Coaches and team staff MUST wear the wristbands provided. Bolton Metro will NOT be responsible for any unaccompanied swimmers on the poolside. The responsibility falls on the club entering the swimmer.

*Bolton Metro will waive the Poolside Passes fee for any club providing one or more technical officials for both days. Please complete a poolside pass request and make this clear on the form.

Spectators

Spectators passes will be available for purchase from the front desk on each the day of the event for £5.00 for an all day pass.

Anyone wishing to take still or digital photography (including using mobile phones) must do so in accordance with Swim England Photography Guidance (see Wavepower 2020-2023). Flash photography is strictly prohibited at all times.

BMSS: Affiliated to Swim England

The meet will be held under Swim England Technical Rules (with a one-start rule) on Saturday 7th & Sunday 8th December, at Jason Kenny Centre, Moor Lane, Bolton, BL3 5BN. The pool is 8 lane anti-wave, 25m, and electronic timing will be used. The competition is open to amateurs only, as defined by ASA Law.

1. Meet Administration

- 1a. The meet will be license at level 3
- 1b. The Promoter reserves the right to reject any entry. (THE PROMOTER BEING Bolton Metro Swim Squad).
- 1c. The Promoter reserves the right to limit entries to meet gala license timing restrictions. Where this rule is invoked, the meet will be filled based on FIRST COME, FIRST SERVED. Rejections will be made in each event rather than by club to ensure the smooth running of the competition. Events chosen for restrictions will be at the meet organisers' discretion.
- 1d. The Promoter accepts no responsibility for loss or damage to the competitor's personal belongings, how so ever caused, unless the negligence of the the promotor causes such damage.

2. General Conditions

- 2a. This meet is open to all members of clubs affiliated with Swim England/Scottish Swimming or Swim Wales or their national association as appropriate. They must be eligible to compete and may enter only in the name of one club.
- 2b. This meet will be run using the linked SportSystems software. The SportSystems entry file will be available to download from our website on the 01/09/24
- 2c. This Competition is licensed by the Swim England (SE) and will be held under SE Laws and Regulations, SE Technical Rules of Racing and to SE Open Meet Licensing Criteria

3. Age Groups

- 3a. Ages are as at midnight 8th Dec 2024
- 3b. Age groups for awards are: 9, 10, 11, 12, 13, 14, 15, 16/over

4. Events

- 4a. Individuals Events:
 - i. 50m, 100m, 200m, 400m, 800m and 1500m Freestyle
 - ii. 50m, 100m, 200m Backstroke, Breaststroke and Butterfly
 - iii. 200m and 400m Individual Medley
- 4b. Events are seeded on submitted times. The Promoter reserves the right to reduce the number of entries to keep the meet to a reasonable length even if swimmers have achieved the minimum qualifying standards.
- 4c. All entries and rejections will be posted on the Bolton Metro website www.boltonmetro.com.
- 4d. All individual events are available for both Open and Female competitors.
- 4e. The Female category is for birth sex females in accordance with Swim England's Transgender and Non-Binary Competition Policy. By entering the 'Female' category, a swimmer confirms that their birth sex is female.
- 4f. A draft programme, final programme and live results shall be published in addition to these conditions.

5. Entries

5a. Upper qualifying times apply to all swimmers.







- 5b. All entries for individual events together with the appropriate fees must be received by the Competition Secretary compsec@boltonmetro.com no later than the published closing time and date.
- 5c. Closing dates for entries will be 11:59 pm 23/11/2024.
- 5d. Any Electronic or postal entries received after the closing date will not be accepted.
- 5e. Entry times achieved in either 50m pool or converted 25m times are permitted.
- 5f. Entries shall be accepted from Classified disability swimmers without the requirement of having achieved a consideration time.
- 5g. No poolside entries will be accepted.

6. Meet Procedures

- 6a. All individual events are Heat Declared Winners. Swimmers will compete in one age group only
- 6b. Competitors whose entries have been accepted will be expected to swim unless they have complied with the withdrawals procedures.
- 6c. Strictly no diving in or climbing over pads is permitted during warm-up in the competition pool.
- 6d. All starts will be into deep water. "Over the Top" starts will be used for all events, including Backstroke events. Swimmers must leave the water by the side of the pool and not over the timing pads.
- 6e. Please note there is no swim-down facility at the pool.
- 6f. All competitors must go through marshalling. If a competitor does not report to marshalling in time, the event will proceed without the competitor.
- 6g. Warm-up protocol: Each warm-up session will be divided into equal-length sessions. There is to be strictly no diving during warm-up, with the exception of designated sprint lanes. Odd lanes will swim clockwise, and even lanes will swim anti-clockwise.
- 6h. All team staff must be DBS checked and have undertaken a relevant safeguarding course (e.g., Swim England Safeguarding course) to gain a coaches/team managers pass and access to poolside and the swimmer's seating area. Any parent of a swimmer attending without their club wishing to chaperone their child must also be DBS checked to gain a pass. Coaches and team staff MUST wear the wristbands provided. The Promoter will NOT be responsible for any unaccompanied swimmers on poolside. The responsibility falls on the club entering the swimmer.
- 6i. The Promoter reserves the right to refuse admission to any competitor or spectator.
- 6j. ALL swimmers must abide by the Health and Safety rules that are on display at poolside. Any swimmer contravening these rules may be excluded from the remainder of the meet. No glass bottles on poolside. Shoes to be worn when leaving poolside
- 6k. NO DIVING AT THE SHALLOW END AT ANY TIME.
- 6l. The Referee's decision regarding interpreting and judging any ASA rules or laws are final.

7. Withdrawals

- 7a. An online withdrawal system will be in operation for the duration of the competition.
- 7b. Withdrawals from Heats must be made no later than 50 min before the advertised competition start time of the relevant session.

8. Awards

- 8a. The 3 fastest times of the swimmers in each age group will receive an award.
- 8b. Medals for para swimmers will be awarded on a multi-classification basis and will be allocated to the top three British Para Swimming (BPS) points scorers in each event







9. Refunds

- 9a. Refunds will not be given for swimmers withdrawing after the closing date or for any errors or omissions attributable to the individual or their club. Refunds will only be issued to individuals who can prove that they are unfit to compete on medical grounds subject to an appropriate medical certificate being received by the Meet Promoter.
- 9b. If cancellation of the event is necessary, then the only claim will be the entry fees paid.
- 9c. All rejected swim refunds will be returned to the relevant clubs.

10. General

- 10a. Bolton Metro Swim Squad will acknowledge receipt of entries as soon as possible after receipt.
- 10b. Receipt of entries does not constitute acceptance.
- 10c. A list of accepted entries will be published on the Bolton Metro website www.boltonmetro.com as soon as possible after the entry deadline.
- 10d. Payment procedure:

- 10f. Entries and results will be managed via computer and available via the internet. Personal data, including submitted and recorded times, will be available during the meet.
- 10g. Throughout this event Bolton Metro Swim Squad will have a number of authorised media partners taking static photographs and video footage. These images are intended solely for the purposes of promotion and celebration of the activities. Consent is deemed to be granted by entering the meet.
- 10h. Flash photography is prohibited at all times during the Meet. Any photos taken should fall within the Swim England guidelines at https://www.swimming.org/swimengland/wavepower-child-safeguarding-for-clubs/. The publishing of a photograph of a swimmer under 18, either on a notice board or in a published article or video recording (including video streaming) of the Meet should only be done with parental consent and in line with Swim England guidelines.
- 11. Any point not covered by these conditions will be at the discretion of the meet promoter. Depending upon the situation, the meet promoter's or Referee's decision, respectively, will be final.
